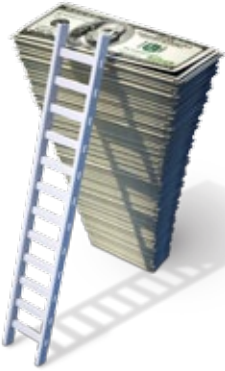

Frequently Asked Questions

Accelerated Double Rank Advancement Bonuses

1. *What are the dates of this promotion?*

November 1, 2010–January 23, 2011.

2. *At what ranks do the Double Rank Advancements start?*

- Star Consultant - 5 personally-enrolled Paid-As Consultants (At least one Consultant on your right and left sales team).
- Crystal Executive - 10 personally-enrolled Paid-As Consultants (5 on left and right sales teams).
- 1-Star Golden Circle – Paid-As Executive = 10 cycles.
- 2-Star Golden Circle – Paid-As Executive = 20 cycles.
- 3-Star Golden Circle – Paid-As Executive = 40 cycles.

3. *Who can participate?*

All existing Associates who have not reached the level of 3-Star Golden Circle (Paid-As Executive).
All new Associates enrolled from November 1 – January 23, 2011.

4. *What dates do I have to achieve the various ranks?*

- If you are an existing Associate or Consultant you must achieve Star Consultant by Sunday, Nov. 21. Any new enrolled Associates have 2 full weeks from time of enrollment.
- After reaching Star Consultant you have 4 weeks to achieve Executive/Crystal Executive (by the end of your 6th week).
- After reaching Executive/Crystal Executive you have 4 weeks to achieve 1-Star Golden Circle - Paid-As Executive (by the end of your 10th week).
- After reaching 1-Star Golden Circle you have 4 weeks to achieve 2-Star Golden Circle – Paid-As Executive (by the end of your 14th week).
- After reaching 2-Star Golden Circle you have 4 weeks to achieve 3-Star Golden Circle - Paid-As Executive (by the end of your 18th week).
- You have a total of 18 weeks to achieve all of the ranks and receive Double Rank Advancement Bonuses.

5. *If I'm an existing Star Consultant enrolled prior to Nov. 1, 2010 how can I qualify?*

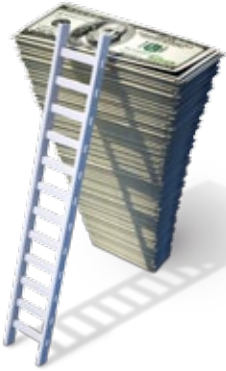
- Since you are already a Star Consultant you will not receive the Star Consultant Accelerated Bonus.
- You still have the opportunity to qualify for Executive/Crystal Executive in the next 4 weeks.
- You then have 4 weeks to qualify for 1-Star Golden Circle (Paid-As Executive), 4 weeks to qualify for 2-Star Golden Circle (Paid-As Executive) and 4 weeks to qualify for 3-Star Golden Circle (Paid-As Executive).

6. *If I hit any of the ranks quicker than the outlined dates, do I still get Double Rank Advancement Bonuses?*

Yes! We encourage you to achieve these ranks faster than outline. It just means you'll earn your money even faster. You must achieve the ranks within the set timeframe, but can do it as fast as you would like.

7. *What does the "Open Week" mean to me?*

- There is no need to wait or hold back advancements this week. Advancements this week also qualify for double Rank Advancement Bonuses. So the sooner you begin advancing, the sooner you begin to earn bonuses.
- All Associates enrolled prior to Nov. 1, 2010 as well as Associates enrolled from Nov. 1–7, 2010 are currently in their "open week" from Nov. 1–7. This simply means that this is a week for you to soak in the information and focus on setting your goals to start participating starting Monday, November 8, 2010.
- All newly-enrolled Associates will have an "open period". For example, if Joe is enrolled on Thursday, November 18, 2010 he will have until Sunday, November 21, 2010 as his open period. He must then start qualifying for Star Consultant in two weeks starting Monday, November 22, 2010.

8. *If I miss any of the Double Rank Advancement Bonuses in the Accelerated timeframe will I still receive my normal Rank Advancement Bonuses?*

Yes, the Accelerated Bonuses are in place to help you set goals and to make money quickly; however, if you choose to do it at a more leisurely pace outside of the set time frames, you can still take advantage of our Rank Advancement Bonuses.

9. *Do I have to be a “Paid-As” Executive to qualify for the 1, 2, 3-Star Golden Circle Accelerated Bonuses?*

Just like the normal Rank Advancement Bonuses, in order to qualify you must achieve “Paid-As” Executive at least one day within the week you qualify for your 1-, 2-, or 3-Star Golden Circle (Paid-As Executive) Accelerated Bonuses. Like the normal Rank Advancement Bonus promotion, you must qualify twice in order to receive the entire bonus.

10. *What countries can participate in the Double Rank Advancement Bonuses?*

United States, Canada, Mexico, Puerto Rico.

11. *If I’m an existing 3-Star Golden Circle and have only qualified for the title once, am I eligible to qualify for Double Rank Advancement Bonuses once I achieve 40 cycles or 3-Star Golden Circle again?*

No, you are not able to qualify for the 3-Star Golden Circle (Paid-As Executive) Accelerated Bonus once you reach this status; however, if you’ve only qualified for ½ of your normal Rank Advancement Bonus you can still qualify for the other ½ by reaching 3-Star Golden Circle again.

12. *When will I be paid out on the Double Rank Advancement Bonuses?*

All commissions are a week in arrears, and a commission week is from Monday–Sunday. You will be paid out in normal commission fashion. (i.e., You qualify for an Accelerated Bonus on Monday, November 22, 2010. That commission week closes on Sunday, November 28, 2010 and would be paid out the week of December 6, 2010.)

13. *What if I’m a 3-Star Golden Circle now but I’m only cycling as a 1-Star Golden Circle with 10 cycles. Can I participate?*

No, because you’ve already achieved the rank of 3-Star Golden Circle (Paid-As Executive) you cannot participate in the Double Rank Advancement Bonuses.

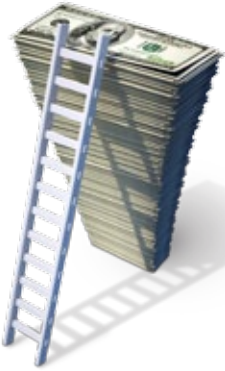
14. *What if I advance to 1-Star Golden Circle within the scheduled period, fall off and don’t qualify for 2-Star Golden Circle then, catch up and qualify for 3-Star Golden Circle within the time frame. Do I earn the 2-Star and the 3-Star bonuses?*

You will receive regular Rank Advancement Bonuses for the 2-Star Golden Circle (Paid-As Executive) Advancement, but you would not receive the Double Rank Advancement Bonus for 2-Star Golden Circle (Paid-As Executive) since you did not achieve the rank within the timeframe. You would also still be eligible to receive the regular Rank Advancement Bonus and the Double Rank Advancement Bonus for 3-Star Golden Circle (Paid-As Executive).

15. *What if I achieved 1-2 Star Golden Circle when there were not Rank Advancement Bonuses in place and my cycles are currently below a 1-2 Star Golden Circle? Can I re-qualify again and receive the bonuses?*

If you’ve already achieved the rank of 1-2 Star Golden Circle when Rank Advancement Bonuses were not in place you can not re-qualify under the new rules; however, since you’ve never achieved the rank of 3-Star Golden (Paid-As Executive) Circle you will still have the opportunity to participate in the 3-Star Golden Circle (Paid-As Executive) Accelerated Bonus by achieving that title in 4 weeks.

16. *What if I am a new Associate that enrolls on January 22, 2011, can I participate?*

Yes, you can enroll to participate in this program through January 23, 2011. Even though the contest period ends on January 23, 2011 Associates registering on or before that date will still be given 18 weeks to receive their Accelerated Bonuses.

17. *Do I have to qualify for these bonuses twice to be paid out the full amount of the Double Rank Advancement Bonuses?*

Yes, you have 4 weeks to earn the first half of the bonus. If you earn the first half of the bonus, you will have an additional 4 weeks to earn the second half of the bonus.

18. *What if I don't earn the first half of the Double Rank Advancement Bonus in the qualifying 4 week period, can I still earn the second half of the bonus?*

No, you must earn the first half of the Accelerated Bonus in order to qualify to earn the second half.
